

RESOLUTION OF THE MUNICIPAL ASSEMBLY OF SALINAS, PUERTO RICO
AUTHORIZING THE MAYOR OF SALINAS TO FILE AN APPLICATION FOR
SPECIAL ADJUSTMENT ASSISTANCE PROGRAM ON THE AMOUNT OF \$75,000.00
FOR THE DEVELOPMENT OF AN ECONOMIC ADJUSTMENT STRATEGY PLAN, AND
AUTHORIZING THE MAYOR TO ACCEPT AND RECEIVE SUCH GRANT.

- WHEREAS : The Municipality of Salinas has suffered an economic dislocation as a result of the closing of the Aguirre Sugar Mill and the Salinas Manufacturing Corp.
- WHEREAS : The Municipal Administration is committed to avert the economic distress created by such closings.
- WHEREAS : The U.S. Economic Development Administration authorizes the Regional Director to make grants to units of general local governments to help finance Economic Development Programs.
- WHEREAS : Under the regulation of the U.S. Economic Development Administration the governing body is required to authorize the mayor to file an application and to provide to E.D.A. with certain assurances of compliance.
- WHEREAS : The principal object of the application is to secure funds for the preparation of an economic strategy plan for the Municipality of Salinas.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL ASSEMBLY OF SALINAS, PUERTO RICO:

- SECTION 1.: That the mayor be and hereby is authorized to execute and file the application in behalf of the Municipality of Salinas to the Economic Development Administration for a grant in the amount of \$75,000.00 pursuant to develop an economic adjustment strategy plan.
- SECTION 2.: That the mayor is hereby authorize and designated as the Municipality representative and as such to act in any application pursuant to such grant and to provide any additional information as may be required including all understanding and assurances contained in said application.
- SECTION 3.: That the mayor is hereby authorized to execute any contract and or agreement with the U.S. Economic Development Administration in connection with said application and he or his designee is further authorized to request and expand funds for the U.S. Government pursuant to said contract or agreements.
- SECTION 4.: That the mayor use such E.D.A. grant to prepare an Economic Adjustment Strategy Plan.
- SECTION 5.: This resolution shall take effect immediately.


