RESOLUCION DE LA ALFABICADA DE LA ALFABICADA

RESOLUCION PROVISIONAL DEL GOBIERNO MUNICIPAL DE SALINAS, PUERTO RICO, EN LA CUAL SE APROBABA LA ALFABICADA DE LA ALFABICADA.

- Que: Under the terms of Public Law 87-678, approved September 14, 1962, the United States of America has authorized the making of grants to aid in financing construction of specific public works projects, provided the proposed or planned total expenditure of the public body for its capital improvements projects is increased by an amount approximately equal to the non-Federal funds required to complete such public works projects:

1. That as of July 1, 1963, the Municipality of Salinas, Puerto Rico thereafter called the "Applicant" had a regular budget in force and effect for the fiscal year 1963-64 which budget provided for capital improvements in a total amount of \$_____.
2. That as of September 14, 1962, in addition to said item of capital improvements in its regular budget, the Applicant had an authorization to issue general obligation bonds to finance public works and provide for other municipal needs for a total amount of \$_____.
3. That the Applicant has heretofore filed an application (s) with the Housing and Home Finance Agency for a grant(s) to aid in financing the construction of the following project(s) (hereafter called "Grant-Assisted Public Works"):
4. In compliance with the terms of the Federal Grant, the Applicant shall provide funds for the financing of the difference between the total cost of the Grant-Assisted Public Works project(s) and the Federal Grant, such funds to be made available from sources in addition to those in the budgetary item for capital improvements.
5. That the Applicant shall not delay or postpone the construction of capital improvements it has otherwise undertaken or planned to undertake in addition to the Grant-Assisted Public Works project(s), and that the construction of the Grant-Assisted Public Works project(s) shall constitute an increase in the municipal construction of capital improvements.

CERTIFICATE OF RECORDING OFFICER

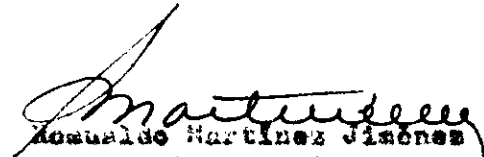
