WHEREAS, there has been filed with the Government on behalf of the Municipality of Salinas (herein called the Applicant), certain applications for Federal assistance under the Public Works Acceleration Act, Public Law 87-658, TO WIT:

NEW, THEREFORE, be it Resolved by the Municipal Assembly of the Municipality of Salinas, Puerto Rico:

1. That the Mayor of this Municipality is hereby authorized and directed to accept any future Grant Offers tendered by the Government under the Public Works Acceleration Act, to aid in the financing of the Projects listed in the first WHEREAS clause of this Resolution.
2. That this Resolution being of an urgent and necessary character shall take effect immediately upon its approval by the Mayor.
