
FAIR HOUSING ORDINANCE

TO ORDER THE MUNICIPAL GOVERNMENT ADMINIS-  
TRATION TO MAKE ALL NECESSARY EFFORTS AND  
TO TAKE THE NECESSARY STEPS TO AID LOW AND  
MODERATE INCOME RESIDENTS TO OBTAIN AND  
LIVE IN ADEQUATE HOUSING UNITS CONSISTENT  
WITH THE NATIONAL GOAL SET BY THE UNITED  
STATES CONGRESS TO PROVIDE A DECENT HOME TO  
EVERY FAMILY IN THE NATION


- WHEREAS : The Constitution of the Commonwealth of Puerto Rico Forbids Dis-  
crimination in Education, Employment and Housing on the grounds of  
Race, National Origin, Color, Sex, Religion or Economic Status.
- WHEREAS : The Municipal Government of Salinas is Ruled within the Frame of  
Said Constitution and Endorses the Policy Contained Therein Against  
Said Discrimination.
- WHEREAS : It Has Been and Will Be the Policy of the Municipal Government of  
Salinas That Every Resident Low and Moderate Income Family will be  
Provided with Safe, Healthy and Adequate Housing Facilities Where-  
ever and Whenever Possible.
- WHEREAS : It is a Fact That Many Low and Moderate Income Residents Are Not  
Able to Provide Their Families with Adequate Living Facilities Due  
to Economic and Other Reasons.
- THEREFORE : THIS MUNICIPAL ASSEMBLY RESOLVES THAT:
- Section 1 : The Municipal Government of Salinas will make all necessary efforts  
and will take all necessary steps to aid, all residents, but specially  
the low and moderate income ones to obtain and live in safe, healthy  
and adequate housing units. Thus, the Municipal Government will  
take all necessary steps towards the national goal of providing  
sufficient, decent and adequate housing units for all families,  
specially to those of low and moderate incomes.
- Section 2 : The Mayor's Office and its staff will be alert to any proceedings  
in the local, state or federal governments which might minimize  
efforts put forth for the provision of housing for low and moderate  
income families.
- Section 3 : The Municipal Government of Salinas will always promote the dis-  
cussion and dealings with this issue at all appropriate forums.
- Section 4 : The Community of Salinas will be informed as to this issue during  
the required Public Hearings prior to submission of any application  
for federal assistance to the Department of Housing and Urban  
Development.
- Section 5 : Copy of this Municipal Ordinance must be submitted jointly with any  
application for funds to any Federal Agency which might require

evidence as to the Municipal performance in housing or housing efforts.






