- Por Cuanto: Es un principio cardinal en el orden de nuestra sociedad que toda persona que infrinja las leyes del Estado deben pagar a la sociedad por el crimen cometido.
- Por Cuanto: Es tambien reconocido dentro del campo de la penologia moderna que el castigo tiene que ir enmarcado dentro de una función rehabilitada que propenda a conseguir que el penado se reincorpore a la sociedad en una capacidad util y creadora.
- Por Cuanto: Según información recibida, el Sr. Harry Rodríguez ha purgado ya cinco años de prision de una condena por la comisión de un delito.

- Por Cuanto: RESUELVASE COMO POR LA PRESENTE SE RESUELVE POR ESTA HONORABLE ASAMBLEA MUNICIPAL DE SALINAS, PUERTO RICO:
- Sección 1ra: Solicitar como por la presente se solicita de la Hon. Junta de Libertad bajo palabra del estado de Nueva York que en el ejercicio de sus funciones discrecionales adelante a la fecha más proxima posible la consideración del caso del Señor Harry Rodriguez y que además le otorgue los beneficios de una Libertad bajo palabra a tenor con lo anteriormente arriba expresado.
- Sección 2ndo: Que esta resolución pidiendo denuncia por ser de carácter urgente comience a regir inmediatamente después de su aprobación por el cuerpo.
